This notice is being provided to advise you and your residents of the FPL utility works are being scheduled along Collins Ave. between 91<sup>st</sup> St. and 92<sup>nd</sup> St beginning 8/26/24 and ending approximately 10/7/24. Reference the attached Aerial View for scope of work limits and during this (6) Six-week period of work, the two North bound lanes along the east side of Collins from 92<sup>nd</sup> street to 9149 Collins ave will be closed for safety. Residents will always have access to their driveways, and we will coordinate with you regarding any activities that might temporarily impact this access. All Pedestrian traffic need to cross Collins from east to west at 90<sup>th</sup> Street and 92<sup>nd</sup> Street intersections.

The work listed below has already been approved by FDOT, the Town of Surfside Building Department, and the Town of Surfside Public Works Dept and FPL. As a neighbor within 300 feet of the site, you are being notified of this anticipated blockage of a public right-of-way in compliance with the Town of Surfside Ordinance No. 2022 - 1720. 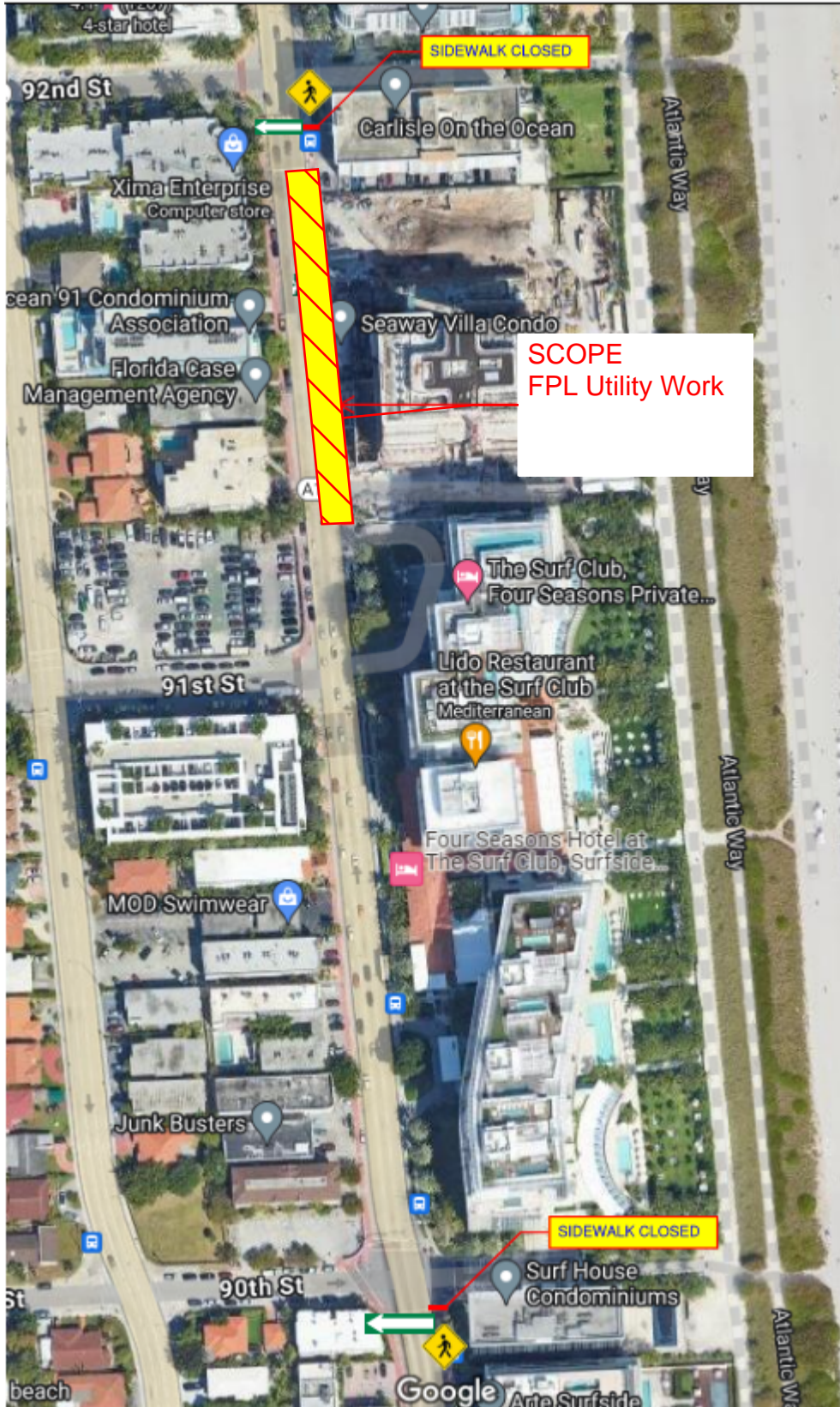

We are writing to inform you about an upcoming FPL utility project on Collins Ave., extending from 92<sup>nd</sup> St to 9149 Collins Ave, Surfside, FL 33154.

Construction activities are scheduled to take place from 8:00 PM to 5:00 AM beginning August 26, in accordance with the guidelines set forth by FDOT, The Town of Surfside Public Works, and FPL. We anticipate the project to be completed by October 7<sup>th</sup>. We will strive to minimize noise and disruption throughout the construction period.

Please note that due to the scope of our work, two northbound lanes will be closed on Collins Ave during working hours (8:00 PM to 5:00 AM).
